TERMS AND CONDITIONS:

All applicants must read the following terms and conditions for adoption from LaMa Animal Rescue

(Hereinafter "LaMa") and initial on the line after each statement. Any modification of these terms must be approved

In writing by a representative of LaMa and initial by said representative.

1. All adults are spayed or neutered prior to adoption. I agree to have my puppy spayed or neutered no later than 6 months of age and provide a copy of the vet bill showing proof of spay/neuter. _____
2. I agree to have the pet examined by a licensed veterinarian at least once each year and provide for all vaccinations and treatments necessary to ensure good health, including but not limited to heartworm preventative, rabies vaccines, vaccine boosters and deworming. _____
3. I agree that the pet will be confined inside the home when no one is at home. _____
4. I agree to have a clean, secure fenced area for the pet. If I use an invisible fence, I agree to proper and sufficient training before releasing the pet inside the system. If a fenced enclosure is not available, I agree to walk the pet with adequate leash and/or harness. Under NO circumstances will I keep the pet routinely on a runner or tie out. _____
5. I will not allow the pet to ride in the bed of a pickup truck, unless kenneled, or loose in a convertible with the top down. I will never leave the pet in a vehicle when temperatures exceed 60 degrees Fahrenheit & I understand that cracked windows are not an exception. _____
6. I agree that the pet will be a family companion. I agree to provide the pet with a safe home, adequate food and water, proper care, exercise, love and attention. I will NOT use the pet for trained attack or protection purposes, nor will the pet be used for commercial guard work. _____
7. I agree to notify LaMa of a change in address and/or phone number within two (2) weeks of such change. _____
8. I am aware of all local laws regarding registration and permitted breeds, and I understand that violations will jeopardize my pet's well-being and/or life. As such, I agree not to violate these laws or ordinances with the pet. _____
9. I will allow LaMa, at their discretion, to conduct home visits, phone check-ins and periodic vet checks at any time after the adoption in order to evaluate the pet's welfare, and I understand that LJR is available for consultation, advice and assistance pertaining to the health, training and compatibility of the pet. _____

10. If for ANY REASON whatsoever, I am unable to keep the pet for its entire life, I agree to return the pet to LaMa. I will NOT give away, sell or dispose of the pet BY ANY MEANS without express written consent of LaMa.

11. I understand and acknowledge that, while LJR has made every effort to provide an accurate history and assessment of the pet, LaMa is not able to guarantee the pet's age, breed, health, history, temperament, disposition or behavior, and LaMa makes no guarantee or statement regarding any of the aforementioned factors. I also understand that by signing this adoption agreement, I accept the above-named pet "as is" with all defects, either observable or non-observable, and I assume all responsibility for the pet, including all risks inherent to pet ownership. Furthermore, I agree to release, indemnify and hold harmless LJR and any of its directors, officers, employees, members, agents and/or representatives from any and all possible claims arising from damages, injury or possibly even death caused by the pet to any person or property. _____
